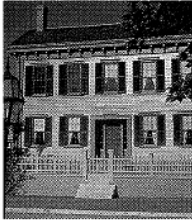

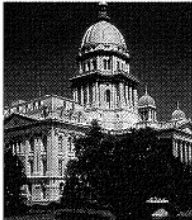
6:00 AM Students report to Hauser Junior High School.
